I. Topic Summary:

Abortion is one of the most debated topics in the U.S. and is a growing concern worldwide. Those who support the "right to life" do so on the basis of biblical, human rights and human dignity standards. Those who support women's "right to choose" do so based on reproductive and women's rights based on constitutional protections. Much of the debate centers on whether an unborn child can and should be concerned a person with inherent value as a person.

While reported abortions have been decreasing in the United States since 2011, as of 2015 it is estimated that 906,000 abortions occurred based on available data. California, New York had the highest incidences and Wyoming and the Dakotas had the least. Abortions occur disproportionately among women of color, particularly African-American women and also among economically disadvantaged women.

Internationally, abortion affects millions of women and raises related cultural concerns. Infanticide and specifically gentricide are more common in other countries, particularly

in the developing world, China and other non-Western cultures. In addition, there are various health and societal concerns associated with abortion in various parts of the globe.

This video discusses some of the key aspects of the abortion debate, the basis for varying perspectives, and the impact of abortion both in the U.S. and globally.
